

OFFICIAL DERBY RULES

- Conducted under the rules and regulations of the current NYS Dept. of Environmental Conservation Guide.
- The Derby will be held on Seneca Lake, May 29th, 30th & 31st, 2021
- Contestants must be pre-registered.
- All eligible occupants of any participating boat must be registered.
- Trout or Salmon caught in Seneca Lake only will be eligible for prizes.
- A contestant is not eligible to win more than one award with the same fish.
- Fishing will be from 5:00 am Saturday to 12:00 noon Monday.
- Fish must be checked in at Geneva Weigh Station prior to 7:30 pm on Saturday and Sunday. At Watkins Glen and Sampson State Park (SamSen Marina) weigh stations, fish must be checked in prior to 7:00 pm on Saturday and Sunday. On Monday fish must be entered prior to 12:00 pm at all weigh stations.
- Contestants must present Registration Card for prize.
- Official headquarters at Geneva, NY.
- Derby Judges will officially judge all fish entered in the Derby and their decisions will be final.
- Any winner may be required to take a Polygraph Test and must produce a valid N.Y. State Fishing License.
- In the event of ties, prizes will be split.
- Length of fish is first tiebreaker.
